

Subcontractor Flowdowns for U.S. Government Commercial Items Contracts. Where the goods and/or services being procured by Buyer from Seller are in support of a U.S. Government end customer or an end customer funded in whole or part by the U.S. Government, the following terms are incorporated herein by reference.

The following Federal Acquisition Regulation (FAR) clauses and those in subsequent appendices in effect on the date of any orders issued pursuant to the Agreement are hereby incorporated by reference, to the extent they apply to Buyer's Prime Contractor with a higher tier U.S. Government contractor and as appropriate for the dollar value of any order. However, in the event of a conflict between the clauses listed below and the Buyer's Prime Contract, the Buyer's Prime Contract shall prevail. Where applicable, the terms "government", "Contracting Officer", and similar terms shall mean Buyer, and the term "Contractor" and similar terms shall mean Seller.
