

Standard Shipping Instructions (SSI) Brazil (OFSE, IET)

Purpose

The purpose of this document is to detail the requirements of importing materials into Brazil to ensure strict compliance with Brazil Customs laws and regulations, expedite clearance of items imported to Brazil, minimize risk of fines, penalties, and forfeitures in relation to imported goods and to minimize storage/demurrage charges.

Scope

The requirements stated within this document apply to all shipments originating outside Brazil from intercompany shippers or external suppliers which are consigned to any Baker Hughes business (OFSE and IET) locations within Brazil.

Responsibility and Authority

It is the exporting location's responsibility to follow the instructions described in this document to assure complete compliance with Baker Hughes Brazil shipping requirements and Brazil customs laws and regulations. International shipments crossing the Italian border and entering the customs territory of Brazil must be accompanied by required import documents containing full, true and accurate shipping data. Consignors arranging shipments crossing into Brazil boundaries are responsible for providing complete and accurate shipments information and documentation as well as ensuring those shipments adhere to the requirements for Brazil Customs clearance as defined in the procedure.

Description of Activity

Shippers (Intercompany or external suppliers) planning and executing shipments consigned to Brazil shall proceed in accordance with the shipping instructions and specific routing terms set forth below.

11. Restricted Materials

The importation of used material to Brazil, as a rule, is PROHIBITED.

DO NOT SHIP ANY USED MATERIAL TO BRAZIL WITHOUT PRIOR APPROVAL FROM CUSTOMS TEAM through the <u>Hand-Carry Workflow</u>.

Legislation: PORTARIA Nº 23, DE 14 DE JULHO DE 2011 - MDIC

The following items are **PROHIBITED** from entering the Country, so do not bring them:

- Cigarettes and beverages manufactured in Brazil, intended for sale exclusively abroad
- Branded cigarettes not marketed in the country of origin
- · Replicas of firearm
- Animal species of wildlife without a technical opinion and license
- Aquatic species for ornamental and agricultural purposes, without permission of government
- · Counterfeit and / or pirated products
- Products containing genetically modified organisms
- Agrochemicals and their components
- Merchandise harmful to morality, health or public order; and
- Narcotic substances or drugs.

The following items are **RESTRICTED** from entering the Country, so do not bring them without prior approval from Customs Team through the Hand-Carry Workflow:

- · Agrochemicals and their components.
- Animals, plants or parts, products of animal or plant origin, including food, seeds, veterinary products, or agrochemicals.
- Wild animals, Lepidoptera, and other insects and their products.
- Weapons, ammunition, and other products controlled by the Army.
- Gold bars for monetary uses (financial assets), including gold plated, unwrought or in semimanufactured forms, or in powder form (NCM 7108.20.00).
- Sensitive goods; goods for use in the nuclear, chemical and biological area.
- Radiocommunications signal blockers (BSR).
- Toys, replicas and drills of firearms (including air guns or other gas of a kind used in games, practice or sports competitions, firearms). Art. 26 of Law 10,826 of December 22, 2003.
- Cannabidiol, in association with other cannabinoids, among them THC.
- Raw diamonds.
- Cooking gas.
- Fuel.
- Endangered animal and plant species
- Medicines for human use, drugs, pharmaceuticals and related substances, hygiene products, cosmetics, perfumes, household cleaning products, cosmetic or dental products, or biological materials, in vitro diagnostic products, medical products and others similar
- Works of art and other items of historical heritage
- Object presenting archaeological or prehistoric, numismatic or artistic interest
- Genetically modified organisms and their derivatives for research or commercial use
- Gold metal in bar (merchandise) import only by Legal Entity
- Gold metal on bar (financial asset) operation permitted only between authorized custodian institutions
- Raw hides and skins of amphibians and reptiles
- Products marked with counterfeit marks, altered or imitated, or with false indication of origin
- Digital Receivers (not allowed for Federal Police).

Please be aware that commercial invoices used for customs clearance will be consider billing invoice for payment purposes to suppliers (intercompany or external)

Note:

Country of Origin:

Is the country of manufacture, production, or growth where an article or product comes from.

Country of Acquisition:

It's considered the country where the goods were when acquired by importer to be exported to final destination;

Exporter

Manufacture



Country of Provenance:

Is the country where the merchandise was at the moment of its acquisition and from where it left for Brazil, regardless of the country of origin or the final point of shipment.





14. Key Requirements for Packing List (net weights, etc.)

Packing list is a mandatory document to clear Customs in Brazil.

There is no default template for this document. It commonly contains the following elements:

- Total quantity of packages (package)
- Marking of packages
- Identification of volumes in numerical order; and
- (Box, pallet etc.) Containing net weight, gross weight, unit dimensions and the total volume of the load.

15. Special Packing Instructions

- All Wood crate/lashing must be treated and dully stamped according with ISPM15 (International Standards for Phytosanitary Measures No. 15)
- Package must be in good condition
- Packages without wood treatment or without stamp, will be rejected by Customs Authorities and will impact customs clearance of the import material
- All rejected woods will be sent back to the exporter by force of law
- Extra costs, regarding wood rejection, will be sent to Supplier's account.


Legislation: INSTRUÇÃO NORMATIVA Nº 32, DE 23 DE SETEMBRO DE 2015

Art. 12. The application of the IPPC mark on the packaging, supports or wooden pieces, in the rough, which are used as material for making packages and supports, intended for the storage of goods in international transit, must be legible, made in a different color red and orange, preferably by heat engraving the wood or another process that ensures that the brand is indelible and persistent, the use of detachable labels being prohibited.

§ 1 The IPPC mark must be visible, at least on two external and opposite sides of the packaging or wooden support, in the format indicated in the Annex to this Normative Instruction.
